Reporting to the General Manager, the Head Golf Professional is responsible for the day-to-day management and execution of all golf related activities and will play a leading role in aligning the clubs' strategic objectives with golf policies and services. You will be responsible for the management, oversight and staffing of the pro-shop operations, club events & tournaments, club storage, cart storage and practice facilities. You will seek to enhance the customer experience, through innovation, attention to detail and the implementation of a *member-first* focus.

Responsibilities and Duties will Include

- Management, control and supervision of the clubs' golf operations, events, and services.
- You will be responsible for recruitment and training of pro shop and club storage staff; this will include oversight and leadership, managing staff performance and setting standards that deliver a superior customer experience.
- Responsible for setting and managing the pro-shop annual budget.
- Oversight of purchasing, merchandising, inventory management, margin controls and fiscal management of the golf shop.
