

## LGCT ACADEMY Covid-19 Declaration of Health and Operational Compliance

### Ladies' Golf Club of Toronto

This form must be completed prior to visiting Ladies' Golf Club of Toronto. Failure to do so shall result in denial of access to booking tee times and to visiting the property. A parking lot attendant will always be on duty greeting all visitors to ensure that your declaration is on file.

The club appreciates and expects your partnership and cooperation in allowing LGCT to open given the guidelines and social distancing protocol put into effect by the provincial government. We all play by the rules of golf and now request that you observe our rules for operating under COVID-19 restrictions. LGCT is permitting play based on the assurances members/GCHs make to the club and to each other in this document. Accordingly, any false statement could result in legal liability to the member/GCH and/or the club. Further, you agree to observe and fully abide by the rules and regulation prescribed by the club. Any failure in this regard may result in disciplinary action.

As you are aware, the virus can be transmitted by asymptomatic people and accordingly, the statements made by members contained in this declaration cannot provide certainty that the virus will not be transmitted. The club is taking prudent steps to impose and enforce appropriate protocols to keep members/GCHs safe, but there can be no assurance that the virus will not be contracted by players while at the club. This is a risk that each member/GCH must assess themselves, and if they choose to play, to take the risk of either contracting the virus or transmitting it to others.

I hereby declare that neither I nor anyone in my household has experienced any cold or flu like symptoms in the last 14 days including fever, cough, sore throat or respiratory illness or distress. This agreement will remain in effect until the Board of Directors at Ladies' Golf Club of Toronto declare the requirement in this form are no longer in effect.

If I or anyone in my household travels to or has a lay-over outside of Canada after submitting this form, I will then not visit the club for a minimum period of 14 days after the date of return to Canada. This agreement will remain in effect until the Board of Directors at Ladies' Golf Club of Toronto declare the requirement in this form are no longer in effect.
