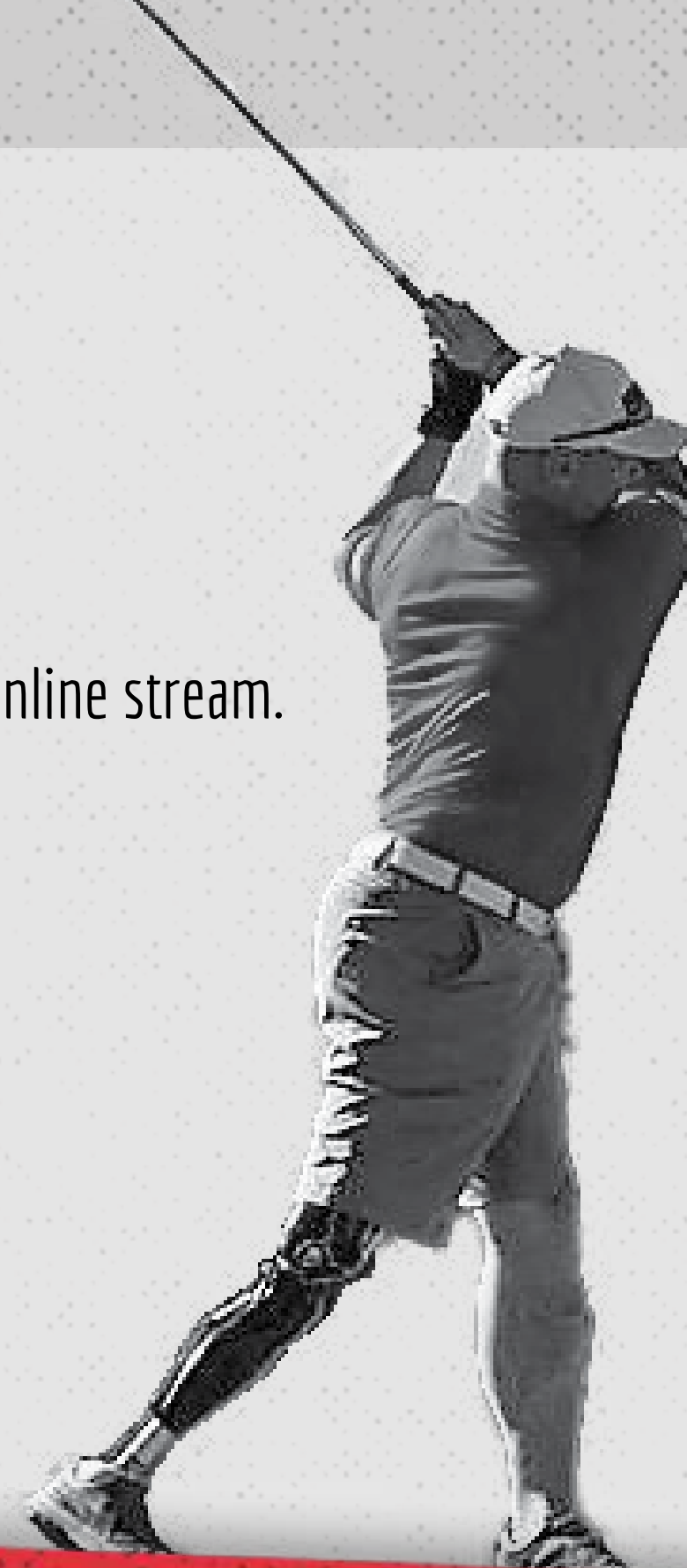

## REGISTRATION & PROXY FORMS

### REGISTRATION

### VOTING MEMBER

Each Individual Voting Member is entitled to one vote, and votes may be cast at the meeting or by Proxy. Voting is limited to Class “A” members of the PGA of Canada.

Proxyholders must be appointed, in writing, by submitting the appropriate proxy form.

To be represented, each Voting Member must complete and submit either a Delegate OR Proxy form by no later than 12:00 p.m. EST on Wednesday, May 5, 2022.
