# DICK MUNN

EXECUTIVE PROFESSIONAL  
OF THE YEAR AWARD



The Dick Munn PGA of Canada Executive Professional of the Year Award is one of the highest honours the association can bestow on a working Executive Professional whose total contributions to the game best exemplify the complete PGA of Canada professional. This award embraces a wide range of services executed by the Executive Professional.

Dick Munn was one of the most influential Golf Professionals of his generation. He was the consummate professional who mentored dozens of Assistant Professionals that went on to be Head Professionals themselves. He was a long-time Head Professional at Point Grey Golf & Country Club, which then led to an opportunity to develop and open Gallagher's Canyon Golf & Country Club in Kelowna. Dick was instrumental in the start-up of Gallagher's Canyon Golf & Country Club. Also, he oversaw the construction and design of The Pinnacle Course at Gallaghers Canyon. From the course design to the clubhouse, to the practice facility, it was Dick's foresight that put this facility on the map and made it what it is today.

In 2010, Dick was honored by the PGA of BC with a lifetime achievement award. The award honors individuals who have made an outstanding contribution to the PGA of BC over an extended period of time through their actions on and off the golf course. This highest level of honor is not one that is awarded every year and has only been awarded nine times in the history of the PGA of BC.

- The annual winner of the PGA of BC Club Professional Championship gets their name engraved on the Dick Munn PGA of BC Club Professional Championship trophy
- In 2010, Dick Munn was Awarded the PGA of BC Lifetime Achievement Award
- The PGA of BC Club Professional of the Year Award is named the Dick Munn PGA of BC Club Professional of the Year Award

## EXECUTIVE PROFESSIONAL OF THE YEAR AWARD GUIDELINES:

- Demonstration of outstanding qualities of leadership.
- Demonstration of outstanding management.
- Maintain a substantial record of service to the Association and the game of golf.
- Well-regarded as a role model to other PGA of Canada Executive Professionals.

## EXECUTIVE PROFESSIONAL OF THE YEAR AWARD CRITERIA:

1. Criteria to Measure
  - a. Overall performance as a Executive Professional.
  - b. Service to the Zone and the Association.
  - c. Leadership ability.
  - d. Image and ability to inspire fellow Executive Professionals.
  - e. Promotion and growth of the game of golf.
  
2. Selection Process
  - a. Nomination should be based on a nominee's entire past experience as a Executive Professional.
  - b. Achievements during the past five years should be emphasized.
  - c. National Awards Committee will select a recipient based on the criteria.
  
3. Eligible Categories
  - a. Must have won this award in your Zone for the current year to be eligible to win this National award
  - b. All Class "A" Executive Professional's in good standing excluding the following: previous PGA of Canada Executive Professional of the Year Award winners, Past Presidents of the PGA of Canada (within the past 5 years), current PGA of Canada Board of Directors, PGA of Canada National staff and PGA of Canada Zone staff.

### NOTE:

- National Awards will be presented in conjunction with Canada Night at the PGA Show in Orlando, Florida.
- In order to win a National Award, the individual member must successfully complete a criminal record check with Sterling BackCheck at [www.sterlingbackcheck.ca/PGA-of-Canada](http://www.sterlingbackcheck.ca/PGA-of-Canada).
- After successfully completing the check, the cost will be reimbursed to the winner of the National Award.
- Deadline to submit – November 7, 2019
