JUNIOR LEADER OF THE YEAR AWARD

The Jack McLaughlin Junior Leader of the Year Award recognizes the PGA of Canada professional who is a leader in junior golf and who reflects the ideals of those who work with youth.

Jack McLaughlin began his career in 1953 at Scarboro Golf & Country Club, and also served as Head Professional at Cedar Brae Golf & Country Club and Bayview Golf & Country Club before relocating to Vancouver's Shaughnessy Golf & Country Club in 1974. McLaughlin also served as President of both the Ontario and British Columbia PGA boards, as well as Director of the PGA of Canada. Dedicated to junior golf and teaching, he taught many of Canada's top players including Lorie Kane, Ray Stewart and Brent Franklin. McLaughlin is also remembered for his commitment to the game, developing junior programs and serving as the National Junior Committee Chair for the PGA of Canada.

- Support of National junior golf programs.

- Proven interest, concern and ability to provide opportunities and experience for junior to learn and play golf.
- Recognized as someone of outstanding character.

## JUNIOR LEADER OF THE YEAR AWARD CRITERIA:

- 1. Criteria to Measure
  - a. Involvement in the promotion and development of junior golf at the club level and within the community.
  - b. Support of PGA of Canada Junior Golf Programs including Future Links and the National Golf in Schools programs.
  - c. Preference will be given to nominees certified in instruction and/or coaching contexts of the PGA of Canada National Coach Certification Program as well as those engaged in learning and certification through other bodies in the industry.
  - d. Overall image, service and leadership in the junior golf arena.
  - e. Overall integrity as an individual.

#### 2. Selection Process

- a. Nomination should be based on a candidate's entire past experience and commitment for continuing one's contributions and assistance.
- b. Achievements during the past five years should be emphasized.
- c. National Awards Committee will select a recipient based on the criteria.
- 3. Eligible Categories
  - a. Must have won this award in your Zone for the current year to be eligible to win this National award
  - b. All Class "A" Members and Candidates for Membership in good standing excluding the following: Life Professional, Retired Professional, previous PGA of Canada Junior Leader of the Year Award winners, Past Presidents of the PGA of Canada (within the past 5 years), current PGA of Canada Board of Directors, PGA of Canada National staff and PGA of Canada Zone staff.

## NOTE:

- National Awards will be presented in conjunction with Canada Night at the PGA Show in Orlando, Florida.
- In order to win a National Award, the individual member must successfully complete a criminal record check with Sterling BackCheck at <u>www.sterlingbackcheck.ca/PGA-of-Canada</u>.
- After successfully completing the check, the cost will be reimbursed to the member.
- Deadline to submit November 7, 2018
