CLUB PROFESSIONAL OF THE YEAR AWARD

The Murray Tucker PGA of Canada Club Professional of the Year Award is one of the highest honours the association can bestow on a working club professional whose total contributions to the game best exemplify the complete PGA of Canada professional. This award embraces a wide range of services executed by the club professional.

A PGA of Canada member for 41 years, Murray Tucker was the first person in the history of the association to earn Master Professional status. While Tucker's playing resume is impressive—winning a number of provincial championships and the 1971 PGA Seniors' Championship of Canada—it's his work with the association where he made his mark. He was Director of the PGA of Canada and the PGA of Ontario for more than 20 years. He completed numerous PGA of Canada employment manuals.

CLUB PROFESSIONAL OF THE YEAR AWARD GUIDELINES:

- Demonstration of outstanding qualities of leadership.
- Demonstration of outstanding management.
- Maintain a substantial record of service to the Association and the game of golf.
- Well-regarded as a role model to other PGA of Canada Club Professionals.

CLUB PROFESSIONAL OF THE YEAR AWARD CRITERIA:

- 1. Criteria to Measure
 - a. Overall performance as a Club Professional.
 - b. Service to the Zone and the Association.
 - c. Leadership ability.
 - d. Image and ability to inspire fellow Club Professionals.
 - e. Promotion and growth of the game of golf.

2. Selection Process

- a. Nomination should be based on a nominee's entire past experience as a Club Professional.
- b. Achievements during the past five years should be emphasized.
- c. National Awards Committee will select a recipient based on the criteria.
- 3. Eligible Categories
 - a. Must have won this award in your Zone for the current year to be eligible to win this National award
 - b. All Class "A" Head Professional's in good standing excluding the following: previous PGA of Canada Club Professional or Club Professional of the Year Award winners, Past Presidents of the PGA of Canada (within the past 5 years), current PGA of Canada Board of Directors, PGA of Canada National staff and PGA of Canada Zone staff.

NOTE:

- National Awards will be presented in conjunction with Canada Night at the PGA Show in Orlando, Florida.
- In order to win a National Award, the individual member must successfully complete a criminal record check with Sterling BackCheck at <u>www.sterlingbackcheck.ca/PGA-of-Canada</u>.
- After successfully completing the check, the cost will be reimbursed to the member.
- Deadline to submit November 7, 2018
