As a previous attendee of the PGA of Saskatchewan Buying Shows, along with our new attendees, please accept this as your invitation to attend the 2022 PGA of Saskatchewan Buying Show, hosted at the Dakota Dunes Resort on October 25 - 26, 2022.

Invitations will be sent to all of our Zone PGA Member clubs, as well as those affiliated with Golf Saskatchewan and the NGCOA. We will also be allowing any qualified buyers admittance into the Buying Show at no charge, provided they have registered in advance. The initial 10' x 8' booth price includes; 8' high back drape, 4' high side drape, 1 - 8' skirted table and 2 folding chairs. Additional booth prices include the pipe and drape only. Hub City Display is once again the Official Display Contractor for the 2022 PGA of Saskatchewan Buying Show, and any additional display requirements or material handling will be arranged through them in advance of the Buying Show. Exhibitor Terms & Conditions - 2022 PGA of Saskatchewan Buying Show

CANCELLATION POLICY & PAYMENT DEADLINE - Cancellations must be made by October 1, 2022. A sum of \$200.00 will be retained as Administrative fees. Cancellations received after this date will forfeit registration fees entirely. No exceptions will be made.

EXHIBITOR'S LIABILITY - The exhibitor is responsible for the merchandise presented at their booth and for insuring their goods with their insurance company. The PGA of Saskatchewan & the Dakota Dunes Resort are in no way and at no time liable for losses or damage to the exhibitor's merchandise before, during or after the Buying Show. Should the show be cancelled, the organizing committee cannot be held liable for losses or damage to the exhibitor's goods if this cancellation results from a natural disaster, an explosion, an act of terrorism, or any other cause beyond the Committee's control. No signs or other articles may be affixed, nailed or otherwise attached to walls, doors, etc. in such a manner as to deface or destroy them. Likewise, no attachments may be made to the floors by nails, adhesives, screws or any other device that would damage them. The exhibitors agree to behave respectfully toward the other exhibitors, attendees, the organizing committee, facility staff and suppliers at the Buying Show. Neither the PGA of Saskatchewan, Dakota Dunes Resort or Hub City Display are responsible for injury to exhibitors' employees, loss or damage that may occur to the exhibitors' property from any cause whatsoever, prior to, during or subsequent to the period of the Buying Show. The PGA of Saskatchewan, Dakota Dunes Resort and Hub City Display do not guarantee or insure exhibitors against loss for any reason. Exhibitors are reminded to verify that their company insurance includes extra-territorial coverage, theft, public liability and property damage insurance.

RENTING SPACE - A space is considered sold once the Exhibitor and Booth Registration Form is signed and Full Payment is received. Space is sold to an exhibitor at the sole discretion of the PGA of Saskatchewan. Due to the limited space available at the Dakota Dunes Resort, if desired, the committee may change the layout or location of an exhibitor's space without notice. The payment deadline for all exhibitors is October 15, 2022. Failure to abide by the deadline will result in booth space being revoked. The exhibitors agree to use the rented space for their own purposes, to sell their goods or promote their services exclusively. Only products and brands represented by the listed Exhibitor Name on the registration form may be present in their booth. The listed exhibitor name may not share the assigned space in part or in whole with any other company or brand unless otherwise approved in advance (for example, Agencies). The exhibitors agree to respect any contract, agreement or collective agreement binding them to the PGA of Saskatchewan and to the suppliers for the show. They also agree to obey the laws of all levels of government and regulations of the fire department. This applies to the material to be sold and to the components of the exhibition booth.

BOOTH ALLOCATION - Booth space is allocated on the basis of several factors and is subject to the discretion of the Buying Show Committee. The Dakota Dunes Resort has limited floor space and therefore the PGA of Saskatchewan may not accommodate all exhibitor requests.
